Overview of Finalized Medicare Provider Enrollment Regulation

Medicare’s final regulation for establishing and maintaining Medicare billing privileges has been released. Don’t miss this opportunity to get up-to-date on the key provisions of this final regulation including CMS’s mandated “revalidation” process that has concerned providers. Learn the following:

- The importance of keeping your CMS-855 information updated or risk losing your billing privileges.
- What “revalidation” means for all those that bill the Medicare program including “non-routine revalidations”
- Why Medicare is emphasizing the importance of site visits as part of this regulation, and

The NPI Enumeration Considerations

CMS released new Medicare CMS-855 forms effective for use on May 1, 2006 which now require NPIs or the new forms will be rejected. So, if you do not have NPIs or are in the process of applying for NPIs you should listen in to learn how to enumerate organizations and subparts with NPIs; Medicare’s policy on NPI enumeration; importance of developing crosswalks, assignment of taxonomy codes; Medicare’s transition policies; and claim form changes.
