Revenue Code Manual Update and Review

The Revenue Code Manual Update and Review will be similar to the Nebraska Chapter's previous Charge Data Master Workshops, providing **two sessions** covering Critical Access Hospital (CAH) and Prospective Payment System (PPS) hospital updates. These sessions will include a discussion of revenue code updates and coverage of those special "Headache Areas" that concern billing and finance. Special focus will be on those areas that cause problems with chargemaster, billing and reimbursement. There will be discussion regarding setting prices based on cost and review charge capture issues.
